If this Waiver and Release is being signed by a parent or guardian on behalf of a minor, I understand and acknowledge that the foregoing agreements and statements are applicable to and require for the minor's participation in the Event and further expressly state that I am authorized to make such agreements and statements for and on behalf of such minor.
